4. Turn **left** at **County Rd 7/Old Augusta Rd**  0.1 mi
5. Take the 1st **right** onto **County Rd 50/Fork Shoals Rd**  2.9 mi
6. Turn **left** at **Ashmore Bridge Rd/County Rd 448**  0.4 mi
7. Take the 1st **left** onto **Bonnie Woods Dr**  0.1 mi
8. Take the 1st **left** onto **Sandy Ln**
